## DECORATION OR INCARCERATION

Scenes from W.W. 1

The following anecdote was submitted from that grand gentleman from Kelowna, O. St. P. Aitkens, MC. This is another of the many fine memories submitted by Paddy Aitkens and he and many others of the "Old Guard" from W.W. 1 are to be complimented for their fine memories and continued support to the Association and The Groundsheet. — Editor.

"I have a German Forage Cap, some German money and a certificate showing that I took it off a prisoner that Captain Bailey and I had captured. This German had the Iron Cross. I also took some parts of a German rifle off him. But the story is actually as follows.

Col. Webb told me that a raid was coming off and asked (rather ordered) me to take my men to listen by the German wire and tell Bailey if there was any suspicion on the part of the Huns that something was afoot. I asked Col. Webb if I could go on the raid and he said no. So I went with my men and when Chas. Bailey arrived, told him everything was O.K. and then asked him if he would like me to join him. He replied, "I would be delighted", so away I went. It was a pretty tough battle. We also had two engineer officers with us with Bangalore Torpedos. I bet one of them 100 francs his would not go off. However it did. I never paid him and have no idea of his name. I filled my pockets from Germans so we could find out who they were and assess their morale. When we reached our lines Bailey had been wounded and we handed the prisoner and the letters over.

Next day Col. Webb had me on the mat and asked me what I had meant by going on the raid. I enquired how he had found out and he informed me that Capt. Bailey had recommended me for the Military Cross. I told him that under the circumstances I must admit that I had indeed been there. He told me that I should be court martialled and asked me how I felt about "swapping" the MC. for a court martial. I replied, "I'll take the MC. Sir. Next day in Battalion Orders I took over from Bailey in charge of Raiding Parties and Col. Webb was delighted that all my men had volunteered to join me.

## FLASHBACK

Athletic achievements have been a tradition of the Westies since way back when as witnessed by this fine article from W.W.1 of Sgt. Hec McDonald of the 47th. — Ed.

Sgt. Hector McDonald (of Vancouver) 47th Canadian Infantry Battalion, winner of the Canadian-Australian Corps, Light Weight Championship at Brussels on March 29th last when he gained a decision, on points, over Phil Moran, Light-Weight Champion of Australia and of the Australian Corps.

Sgt. McDonald, who is 38 years of age, stepped into the ring at 132 lbs., while Moran, who is only 22 years, turned the scale at 136 lbs.

The previous Saturday, McDonald had carried off the Canadian Corps Feather Weight Championship in a bout

fought at the same arena, Viz the Palace des Sports, Brussels, while in 1918 he captured both the Welter and Light Weight events at the Brigade and Divisional sports and also captured the Light Weight at the Corps Sports at Tanks, France, and only lost out, on points, in the Welter Weight class through having to fight both finals without stepping out of the ring while his opponents came up fresh each time. His fighting weight, at the ringside, being 133 lbs.

## THE ROYAL WESTMINSTER REGIMENT ASSOCIATION

Sometime ago President Bert Hoskin requested Norm MacAskill to review the By-Laws and to bring his findings to the executive. Norm has done a fine job and the revised and/or amended format is published for your information. — Ed.

### OBJECTS

1. The objects of the Association are to band together all former members of the Regiment and its predecessors, for the purpose of encouraging and facilitating the study, discussion, and exchange of information and ideas among the members on all questions of interest pertaining to them as citizens and more particularly as ex-soldiers, and to keep alive the spirit of comradeship and good fellowship and the splendid traditions inculcated while in the service, and to be able to meet as an organization, as occasions demand in a fraternal manner and at all times to promote the existing Battalion.

### MEMBERSHIP

2. (a) Membership in the Association is open to anyone who has at any time been affiliated with the Royal Westminster Regiment or its predecessors regardless of duration.
- (b) Any person of good standing, covered by the conditions of the preceding sub-section, wishing to become a member of the Association, shall submit his name in full, name of Unit, Regimental number, rank, present address and occupation, in writing on the form supplied by the Association.

### DUES

3. The annual dues of the Association for its various categories shall be as follows: general membership (under 60 years) and Officers of the Regiment \$5.00, World War One veterans, free, serving members of the Regiment (ranks), \$3.00, Life members, \$5.00 on application and \$3.00 thereafter.

**MEETINGS**

4. The annual general meeting of the Association shall be the general meeting held on the third Tuesday in March in each and every year at 8:00 p.m. or at such time as may be decided by a previous general meeting.
5. Executive meetings shall be held on the first Monday of each month at 8 p.m., or at such time as the Executive may decide. Special meetings of the Executive shall be convened by the Secretary at the instance of the President or upon request of two members of the Executive.
6. Special general meetings may be called at any time by the President and may be called upon request of the Executive or 15 members of the Association. Such request shall state the nature of the business to be transacted at such a special meeting. At least 10 days notice of such special meeting shall be given either by circular letter, post card or by publication in the Association Bulletin.
7. 15 members shall constitute a quorum at a general meeting, Special general meeting or Annual general meeting and no meeting shall be held unless a quorum is present. 6 members shall constitute a quorum for all Executive meetings. All questions shall be decided by a majority vote of those present, and the presiding officer shall have the casting vote in the event of a tie.

**ORDER OF BUSINESS**

8. The following shall be the order of business at general meetings of the Association:—
  - (a) One minute silence in memory of departed comrades.
  - (b) Roll call of officers of the Association.
  - (c) Reading of the minutes of the previous general meeting and the confirmation of same by the meeting.
  - (d) Reading of the minutes of the Executive meeting for information only. Any point of business from the latter may be brought up later under New Business or Good and Welfare.
  - (e) Reading of correspondence and the disposal of same.
  - (f) Reports of Standing and Special Committees.
  - (g) Unfinished business.
  - (h) New business.
  - (i) Good and Welfare.
  - (j) The Queen.

**DEBATE**

9. (1) No debate shall be permitted except on a motion regularly moved and seconded, unless the Chair shall otherwise rule.

- (2) No member shall speak twice on the same motion except by permission of the meeting or by way of explanation except the mover and seconder of the motion in way of explanation or rebuttal.
- (3) Questions of order arising at a meeting of the Association, not provided for in the Bylaws shall be decided by the Chair.

**DELINQUENCY**

10. No member of the Association who is delinquent in dues shall be entitled to vote at any meeting of the Association.

**RESIGNATION**

11. Any member desirous of withdrawing from the Association may do so at any time by advising the Secretary.

**AUDIT**

12. At the first general meeting held in each year the Association shall appoint an accountant to audit the books of the Association. The audited statement shall be presented to the Annual general meeting in March of each year.

**ELECTION OF OFFICERS**

13. (1) At the Annual general meeting there shall be elected an Executive which shall consist of the following:— a President, Vice-President and 8 members. This Executive shall remain in office for one year or until their successors are named. All members of the Executive shall be elected by ballot. The Past President shall be a member of the Executive, ex-officio.
  - (2) The incoming Executive shall each year, appoint a Treasurer and a Secretary at the First Executive meeting after the Annual general meeting from its own members or from the membership at large.
  - (3) The Executive Committee may at any time appoint members to fill vacancies created by resignation, removal or death of any member except in the following cases:
    - (a) in the case of the President, the Vice-President shall become president and
    - (b) an election shall be held for Vice-President. This election shall be held at the next general meeting or at a time designated by the President and he will hold office for the balance of the year.

**ELECTION PROCEDURE**

14. (a) Nominations for the offices of President, Vice-President and members of the Executive shall be made

- by a member of the Association in good standing. Nominees must be present at the meeting or have given written consent and be in good standing.
- (b) Prior to the election of officers, the President shall appoint three members to act as scrutineers, the first named to act as Chairman with power to add to his Committee.
- (c) In the event of two or more being balloted upon to fill the office of President or Vice-President, the highest number of votes will elect. The members, nominated for the Executive, receiving the highest number of votes will be declared elected.

### DUTIES OF OFFICERS

15. (a) It shall be the duty of the PRESIDENT to occupy the Chair at all meetings, to receive and put motions, to inform the Association of the proceedings since the last meeting and to cause the minutes and other communication to be read; he shall sign the former. He shall also inform the meeting of anything he thinks of interest to the members.
- (b) The PRESIDENT, at any meeting, shall enforce order and strict observance of all Association bylaws. He shall have the right to decide all questions of order, subject to an appeal to the meeting sustained by a majority of those present. He shall only vote in the case of a tie vote when he shall have the right of giving the casting vote.
15. (c) It shall be the duty of the President to call special meetings of the Association at any time at the request of the Executive or of fifteen or more members of the Association, giving due notice thereof and giving notice of the purpose for which it is being called, providing always that if the President or Vice-President be absent, any member of the Executive shall be competent to call such a meeting, in the manner aforesaid.
- (d) The President shall appoint the Chairmen of all standing Committees who will appoint their own Committee members subject only to the approval of the President
- (e) The PRESIDENT shall be, ex-officio, a member of all Committees and shall be notified of all committee meetings.
- (f) The VICE-PRESIDENT shall, in the absence of the President perform the functions that would otherwise be performed by the President.
- (g) The SECRETARY shall keep all books, conduct all correspondence, retain copies of all official letters, present all official documents and attend and take minutes of all meetings. At any other time he is requested to do so shall perform such other duties as properly pertain to his office. It shall be his duty to give 10 clear days notice of all regular meetings.
- (h) The TREASURER shall have charge of all funds belonging to the Association and shall deposit same in a chartered bank approved by the Executive. Out of such funds he shall pay by cheque amounts directed by the Executive and keep regular accounts of income and expenditures of the Association. He will present a balanced financial statement to the Executive and the general meeting for approval. He shall sign all cheques, papers, documents, etc., to be countersigned by the President or Secretary.
- (i) CHAIRMEN of Committees shall convene meetings of their committees from time to time and shall preside at all such meetings. They shall announce their committees and bring forward for discussion of all such matters and things as may relate to the object for which such committee was created. They shall attend all Executive meetings and submit such reports and recommendations as directed by their committees and shall be responsible for the proper functioning of their committees.
16. The fiscal year shall end on the last day of March of each year.
17. The President, at any time, may appoint additional members to serve on the Executive Committee.
18. Should any member of the Executive Committee be absent from 3 consecutive meetings of either Executive Committee, general meeting or special general meeting without a reasonable explanation satisfactory to other members of the Executive Committee he shall, if a resolution to that effect is passed by the Executive Committee, cease to hold office.

### TRUST ACCOUNT

19. (1) The Executive of the Association shall be empowered to set up the Westminster Regiment Association Trust Account.
- (2) This fund is to be administered by the Executive of the Association.
- (3) Three Trustees shall be appointed by the Executive with full signatory powers for this Fund; these Trustees, commencing with 1953, be appointed for the following terms of office; one for five years — one for three years — one for two years; and no expenditure be made from this fund, without full authorization, by signature of all three trustees.
- (4) All subsequent appointment of Trustees to be for a period of five years.
- (5) In the case of retirement or death of any Trustee, the Executive is empowered to appoint a replacement for the unexpired portion of the term vacated.
20. The Bylaws of the Association shall not be altered or amended except upon a motion, due notice of which, setting forth the alteration or amendment, shall have been given at a meeting of the Association held previously to

the meeting at which same is to be considered. A majority vote of the members present shall be required to make such proposed alteration or amendment effective.
