Marseilles France	1 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 804 + 35 att.</p> <p>Though the sun was bright, a strong wind prevailed all day, making the camp area miserable with clouds of thick red dust. The carriers were given a move order but this was later cancelled. In the afternoon 100 personnel from Support Coy arrived from Italy.</p>	
	2 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 804 + 35 att.</p> <p>On a further bright but windy day the C.O., Lt. Col. G.C. Corbould, D.S.O. arrived at the staging Camp near Marseilles with the vehicles and the remainder of the unit which was now wholly moved from Italy to France. The carriers were given a move order, were stood down, received an other notice and finally moved at 2200 hrs. Lieut. J.E. Oldfield was again in charge of the party. Orders were received for the unit to move on the following morning and at a conference held at 2200 hrs, Major D.B. McKenzie received more detail. The move time was to be 0730 hrs and the first Staging Camp was St. Rambert, a distance of about 170 miles.</p>	
En Route	3 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 804 + 35 att.</p> <p>The unit was the third in a block of large convoys moving NORTH together. Brig. J.S. Lind, D.S.O. with the B.M., Maj. D. Clarke travelled with the Westminsters who pulled out of MARSEILLES at 0730 hrs. The convoy arrived in St. Rambert at 1815 hrs, approx. 1 hour ahead of schedule. Everyone was under canvass which was fortunate as the weather had changed to a high wind and rain. Orders were to move at 0715 hrs on the next day.</p>	
	4 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 804 + 35 att</p> <p>Capt. K.B. Harrison left early once more with a small advance party of cooks. The remainder of the battalion moved at 0715 hrs, for the next Staging Camp, MACON</p>

En Route	4 Mar 45		<p>continued.</p> <p>NORTH of LYON a long line of burnt-out enemy vehicles gave evidence of the effectiveness of the Allied Air Forces in the early stages of the French campaign. The wrecks were nose-to-tail on both sides of the road and stretched for miles. MACON was reached at 1630 hrs.</p>	
	5 Mar 45		<p>Strength Offrs 34 + 5 att. O.R.s. 804 + 35 att</p> <p>At 0730 hrs the Westminsters moved off on the next stage of the journey to BELGIUM and the remainder of 1 Cdn. Army. The route led generally up the line of the RHONE VALLEY, EAST of PARIS and thence to BELGIUM. The destination for the 5 Mar was LES LAUMES, a town on the ARMANCON River where the unit arrived at 1530 hrs.</p>	
	6 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 804 + 35 att</p> <p>Leaving time was again 0715 hrs, and the unit pulled out of the muddy parking area in a slight, cold rain. The next Staging Camp was MELUN, a large town about 30 miles SOUTH-EAST of PARIS. 1630 hrs was the time of arrival here.</p>	
	7 Mar 45		<p>Strength Offrs 34 + 5 att. O.R.s. 804 + 35 att</p> <p>Starting once more at 0715 hrs, the unit headed for CAMBRAI, the last Staging Camp of the trip. A U.S. Army M.O. Escort accompanied the unit past all the approaches to PARIS. The unit arrived in CAMBRAI at 1530 hrs and staged a short distance outside the town. At a conference held that night it was found that our final destination was to be a small town called DEYNZE, about 15 miles SOUTH-WEST of GHENT. (See map) Time of departure was to be 0930 hrs. Here it was rumoured that there was to be a change in the organisation of the 5th Div in which 12 C.I.B. was to be broken up.</p>

DEYNZE BELGIUM MR050726	8 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 803 + 35 att</p> <p>Leaving CAMBRAI, the unit travelled through parts of country which had seen Canadians in action in World War 1, and arrived at the dispersal point, AUDENARDE, at 1230 hrs where we were met by the advance party. This group of officers had arrived in the area two weeks previously and had arranged billets for the bulk of the battalion in DEYNZE while the Support Company was 5 miles away in AERSEELE. By 1500 hrs everyone had been put into billets. The town was very clean and the people were exceptionally friendly and helpful. The quarters were good, most of the troops having beds to sleep on for the first time in many weeks. It was know made known that 12 Cdn Inf Bde was to be no more. The Westminster Regt (M) was to return to 5 Cdn Armd Bde under the command of Brigadier Cumberland. Changes were being made throughout the whole division in order to conform to, the organization of the other formations in NORTH-WEST EUROPE.</p>	
	9 Mar 45		<p>Strength Offrs 35 + 5 att. O.R.s. 803 + 35 att</p> <p>The weather was back again to sunshine. At 1000 hrs the CO was visited by Brig Cumberland and the <i>DAA & QMG</i> of 5 CAB, J.K. Manuel. The CO and 2 i/c returned with them to HQ 5 CAB which was located about twenty miles away at ISIGHEM. The Brig, wished the unit to be closer to Bde HQ, so it arranged that Advance Parties should go the following day to some small town near ISEGHEM. The unit was to move when the billets were arranged. At last came the news for which everyone had been waiting. Leave to UK had been granted and 70 all ranks were to leave on the 10th of March. The leave provided seven clear days in England. The quota was: 10 Offrs and 60 ORs. The 2 i/c, Adj, IO, Coy Comds and two offrs who had been recently married in UK made up the offrs group while each coy had an allotment of 12 ORs. As part of the reorganization which was taking place, the White Scout Cars were being exchanged for White Half-tracks, an improvement on the older model scout cars. Capt J V H Wilson MC made preparation to leave at 0830 hrs 10 Mar on Compassionate Leave to Canada. Brig, J.S. Lind addressed the battalion in a farewell speech. This marked the end of a successful eight month period with 12 Cdn Inf Bde, which was now being dispensed with from 5 Cdn Armd Div.</p>

Voluntary Church parades were held and were well attended. Corbould DSO, left at 0815 hrs for HQ 5 CAB where he was to take part in a TEWT, (Tactical Exercise Without Troops); Exercise SHERMAN I (See appx). Orders were received that the unit would move from DIENZE to MEULEBEKE in order to be closer to HQ 5 CAB for administrative reasons. This move was slated for 14 Mar 45.</p>	
	13 Mar 45		<p>Strength Offrs 35 and 5 att. O.R.s. 800 and 35 att Again the weather held fair with good visibility. The day was spent in repacking and preparing to move. Lieut. G.B. Eaton, "B" Coy, had gone ahead of the battalion with a recce party to arrange billets. A move was much more complicated now than it had been in the past due to the requirements of billeting regulations. A great deal more time was taken up now in arranging accommodation, where previously, it had been a simple case of taking sufficient quarters.</p>

It was made known that Field-Marshal Sir B. L. Montgomery was to visit the newly-arrived Canadian troops and was scheduled to arrive in the area on Sunday 18 Mar 45. The Westminsters were to line the road of the route and to this end, web belts and anklets were thoroughly scrubbed.

At 1100 hrs word was received that the unit was on 48 hrs notice to move NORTH into HOLLAND to take over a static position in the vicinity of NIJMEGEN. By 1400 hrs this had been reduced to 4 hrs and advance parties were warned for 0735 hrs 18 Mar 45. A battalion parade was laid on for Sunday morning when Field-Marshal Montgomery was to drive through the Div area.

<p><i>En route</i> MULEBEKE - ALPHEN</p>	<p>18 Mar 45 cont'd</p>		<p>DIENZE, GHENT, ANTWERP, BREDA, TILBURG, HERTOGEN BOSCH, GRAVE BRIDGE to WIJCHEN. The Recce Party reached WIJCHEN at 1530 hrs. The CO reported to HQ 49 (WR) Inf Div under whose command the unit was to come. After this the CO returned to VOUGHT where the Advance Parties had located temporary billets in an old S.S. Barracks.</p>	
	<p>19 Mar 45</p>		<p>Strength Offrs 36 and 5 att. O.R.s. 798 and 35 att</p> <p>The weather improved from the previous day with the sun showing through in the afternoon. Visibility was good. A quiet night had been spent except for a number of V-1 Flying Bombs overhead. The CO with coy 2s i/c left at 0810 hrs to recce the positions held by XII Manitoba Dragoons, II Cdn Corps Recce Unit. Bn HQ was located at GREFFELING 444615 on the bank of the MAAS RIVER while Sp Coy less one A/Tk Pl was to be in area OUDEMAASDIJK 408623.</p> <p>“A” Coy took over a three thousand yard stretch of front at WAMEL 4367 and “C” Coy had about the same frontage at DREUMEL 4163. “B” Coy less its Scout Platoon were placed in reserve at ALPHEN 4360. Sp Coys No 15 Pl A/Tk under Lieut. D.A. Jones with 5 Pl of “B” Coy commanded by Lieut. P.M.T. Skrimshire were under command BROCKFORCE on duty at NIJMEGAN BRIDGE. The anti-tank platoon was on anti-submarine watch as attempts had been made by various means to disable the bridge. Under command of the Westminsters was No 12 Coy Dutch Forces of the Interior, the equivalent of the Italian Partisans and of little more value.</p> <p>The recce parties left at 1730 hrs to return to VOUGHT. The relief was to take place on 21 Mar 45.</p> <p>The bulk of the battalion left MEULEBEKE at 0730 hrs and arrived at VOUGHT at 1640 hrs. This was very good time for a large convoy to cover a distance of 200 miles.</p>

The troops were busy oiling and cleaning weapons and generally preparing for battle. Sten Machine Carbines were issued to replace the Thompsons which had been withdrawn prior to leaving Italy.</p> <p>The CO with Echelon comds left at 0930 hrs to recce Echelon areas at HERNEN 5861. Notice was received that the battalion would leave to move into the line at 0900 hrs 21 Mar 45.</p>	
	21 Mar 45		<p>Strength Offrs 36 and 5 att. O.R.s. 797 and 35 att The unit left VOUGHT at 0900 hrs and had completed the take-over by 1530 hrs. The CO, Lt-col Corbould was photographed for the news reels as being the CO of the first unit from the Italian theatre to go into action in NW Europe, a doubtful honour, as his leave had been cancelled when the order came.</p> <p>The first leave party returned from England at about 1800 hrs, very surprised to find the unit in action and equally surprised to find such un-warlike conditions did exist. It was quite amazing to find electric light, running water and radios in forward area, where past experience had been that it was difficult to find one Italian farmhouse which was free from shell damage. A check was to be made by the forward coys, "A", "C" & Sp, for a suitable place to show movies when films could be obtained. This, also, was an innovation for the front line.</p> <p>The night duty at Tac-Main HQ was taken by Capt H.E. Smith, A/Adjt and Lieut. J.E. Oldfield, acting as HQ Coy Comd, Sigs Offr etc. It had been a rather difficult week for the A/Adjt as there had been visits from the Corps Commander, Lt-Gen Foulkes and the Army Gp Comd, Fd Marshall Montgomery, an administrative move, and a tactical move. At times he had been A/Bn Comd. Consequently he seemed pleased to see Bn HQ personnel back from leave.</p> <p>The night was quiet with practically no activity except some enemy MG fire.</p>

O.R.s. 797 and 35 att During the night and early morning a number of V-1 flying bombs went over the battalion area en route to ANTWERP.</p> <p>The weather was sunny and warm. The day was again quiet and was taken up by the companies in tying in positions and lising with DUTCH troops in the area.</p> <p>The G-3 Ops from 49 (WR) Inf Div came around in the morning <i>and</i> at the same time Brig. Cumberland arrived. The Brig stayed a few minutes to discuss the situation with the CO, then left to return to HQ 5 CAB.</p> <p>In the afternoon the CO with the 2 i/c Major D.B. Mackenzie made a tour of the companies. In the evening at about 2000 hrs came the first half dozen V-1s with their roar and exhaust flame.</p> <p>There was some enemy patrol activity in C Coy area at 2300 hrs lasting until 0730 hrs. There was some firing but no one was hit and no prisoners were taken. At 0230 hrs some activity in A Coy Area resulted in Pte KOLLER, W.J. being killed, the first casualty of the units first action in HOLLAND.</p> <p>The remainder of the night was again quiet until 0630 hrs when the “buzz-bombs” started again.</p>

At 1000 hrs the CO, Lt-col G.C. Corbould DSO, received a visit from the GOC 49 (WR) Inf Div., Maj-Gen McMillan, DSO, MC., under whose command the Westmr R (M) was operating. He had requested that the company commanders be present.</p> <p>In the afternoon a sudden flurry of mortaring caused some rapid movement in Sp Coy area and damaged a range finder. A little later B Coy's 3" Mortars which were attached to Sp Coy located the enemy OP and after this had received a short treatment the hostile mortaring subsided.</p> <p>A raid on the enemy held territory across the RIVER WAAL near TIEL sq 4168 had been scheduled for several nights but each time had been postponed due to the bright moonlight. A battalion of the KOYLI were to do the job which entailed moving down <i>the</i> WAAL from DRUTEN Sq 5303 in Royal Navy L.C.As, landing near TIEL to carry out a task of demolition and return to DRUTEN. This operation was known as EXERCISE "HEREFORD". It was cancelled for the KOYLI and given to the Westminsters and to do the job, the CO chose Major E.V. Ardagh's "B" Coy.</p> <p>Further details were to be made known on the following day by a Naval representative and a company commander from the KOYLI.</p> <p>A sweepstake held that evening on the time of passing of the first V bomb of the night failed to materialize in winnings for anyone as no bombs showed up.</p> <p>The night was quiet with some shelling heard on the left but none in the Bn Area.</p>

At 1030 hrs an officer of the L.C.A. flotilla which was to take part in EXERCISE "HEREFORD" accompanied by Coy Comd from the KOYLI came to put Major E. V. Ardagh in the picture. Practice exercises were to be carried <i>out</i> at times to be arranged.</p> <p>In the afternoon the CO visited the OC of the POLISH SP Anti-Tank Battery which was on the Unit's LEFT flank. Their headquarters was situated in LITH 415587.</p> <p>At 2359 hrs a small enemy patrol penetrated C Coy area at 423663, a thinly held piece of ground between C and A Coys. After a short small arms exchange the patrol disappeared.</p> <p>There was some enemy mortaring and shelling during the night but no casualties were caused.</p>	
	25 Mar 45		<p>Strength Offrs 36 and 5 att. O.R.s. 794 and 35 att</p> <p>The bright weather changed to clouds but visibility was good. At 0500 hrs, a standing patrol from Sp Coy led by Lieut. H.A. Stephens and composed of 8 ORs went out to the FACTORY 391622. They were equipped with a No 18 set netted to a No 19 set and were to stay until 2030 hrs. The day was very quiet for the patrol and they came in with nothing to report.</p> <p>In the morning a visit was paid to Bn HQ by Brig. T.J. Rutherford, ED. former commander of 5 CAB. He was accompanied by the CO 11 CAR (Ontario Tank). At 1415 hrs the CO left Bn HQ to attend a conference of commanding officers. This dealt with both present and future operations. On his return he called a meeting of company commanders at which the information was passed on.</p> <p>At 2130 hrs a fire was started by A Coy's 3" mortars in a factory on the enemy side of the RIVER WAAL at 477687. At 0600 hrs a C Coy man was wounded by a stray round from enemy MG harassing fire.</p>

A V-1 flying bomb was reported to have landed near A Coy area but on further investigation it was found to have landed across the river in enemy terretory. An unusual number of projectiles went over during the night which seemed to indicated that Jerry was using up his stocks before the new Allied offensive, EXERCISE PLUNDER should reach his launching sites. There was some light mortaring in Sp Coy area 400630.</p>	
	<p>26 Mar 45</p>		<p>Strength Offrs 36 and 5 att. O.R.s. 793 and 35 att</p> <p>The grey cloudy weather continued but again visibility was good. It was arranged that Major E.V. Ardagh, OC "B" Coy, which was to carry out EXERCISE HEREFORD, would fly over the ground over which the raid would take place. The trip was laid on for 1400 hrs.</p> <p>There was a good deal of discussion amongst the coy 2s i/c and the Technical Adjutant, Capt R. J. Grinsted regarding 60 Cwt Mobile Kitchen trucks which were to become part of unit equipment. As the vehicles were not satisfactory it was decided that, if possible, they would be turned back in favour of the 60 cwts GS which had been the normal cooks vehicles. There were a number of changes being made in the unit's equipment, including the addition of six WASP Flame Thrower Carriers as well as the 6 LIFEBUOY Manpack Flame Throwers. T16 Carriers were to be substituted for the wheeled Gun-Towers with which the Anti-Tank Platoons were equipped and White Half-Tracks were to replace the Scout Cars. TMCs were withdrawn from the unit before leaving Italy and STEN MGs issued on arrived in NW EUROPE.</p> <p>At 1500 hrs, Pte D. Pastro, an A Coy cook, was hit in the back by a rifle bullet from an unknown source. This made the third casualty since taking over the sector.</p> <p>To the joy of all CQMSs it was found that the Mobile Kitchens were to be returned</p>

<p><i>ALPHEN MR 439605 SHEET 5 SW TIEL</i></p>	<p>26 Mar 45 cont'd</p>		<p>A delay was expected in the arrival of other projected vehicle and equipment replacements.</p> <p>The CO Lt-col Corbould DSO left with Major E. V. Ardagh for the 552 L.C.A. Flotilla, R.N. at the NIJMEGAN Power House where they were to have dinner then carry out a rehearsal of EXERCISE HEREFORD. The CO returned at 2300 hrs.</p> <p>Activity on the front started at 2100 hrs when Major W.J. Neill, A Coy, reported a small power boat moving from EAST to WEST in the RIVER WAAL at approx 461683. This was followed by a report that a patrol of 7 enemy had been seen near the FACTORY 446677. This group was fired on by Brens of No 4 Pl and dispersed.</p> <p>A fire had been started in TIEL earlier in the evening by the supporting 4.2 Mortars and at 2140 hrs Major H.F. Hoskin, "C" Coy, reported movement and shouting around the blaze. This was administered by A Coys 3" Mortars and a scale 5 treatment from the supporting troop of 25 prs. Also at 2140 hrs A Coy reported the unidentified river craft to have stopped, so a few rounds of 3" M were placed on the area.</p> <p>At 2145 a flurry of heavy mortar bombs came down on A Coy and the area was shelled causing one civilian casualty. This fire was returned by the 25 prs.</p> <p>At 2300 hrs the enemy commenced to rocket the area. The rockets were of a large calibre and a swell as a heavy HE charge they contained an oily incendiary substance which burned for ten minutes after the explosion. CSM Beltz, C.E. described it as being similar to the explosion of a 77 grenade, except that it was much greater.</p> <p>Harassing fire from enemy MGs was in Sp and C Coy locations all night but no casualties were caused. Corbould, D.S.O., that the Westminster Regt (M) had been selected as the one unit to represent 5 Cdn Armd Div in the Victory March through the streets of BERLIN. This was an honour of the highest order as it intimated the esteem in which the unit was held within the division.</p> <p>By 1600 hrs it was definite that there would be no move before the next day. At 1900 hrs the BCD’s reported firm on “RECORD”. The “Straths” were unable to get on to “STEAMER” due to strong anti-tank opposition and halted for the night about two thousand yards short of the objective. With them was “C” Coy’s Scout Platoon and one Motor Platoon who remained as protection for the tanks.</p> <p>All afternoon prisoners had been streaming in and as usual were from all arms of the decimated enemy forces. They were being captured by the Tech Adj, ration parties, recce parties and anyone who was travelling the roads.</p> <p>During the night, a large enemy force, withdrawing from APELDOORN 7904 attacked 5 C.A.D. at OTTERLOO 6591 and though the attack was unsuccessful and they lost a large number killed, wounded and prisoners, they did manage to cut the road.</p>

However, they occupied only a small portion of the town and the Germans were able to re-occupy some of the area from which they had been cleared. The road WOLDENDORP – TERMUNTEN was under observation and moderately accurate fire from the German guns at 558228 was directed against any vehicle movement. The C.O. went forward to visit “B” Coy and enjoyed this experience while both going up and returning. A house on the road was later set alight while occupied by Lt J.A. Fowlie and his “step-up” station. During the darkness this silhouetted any vehicle and so the ration and ammunition trucks also had their share from the SPIT.</p> <p>“C” Coy sent out a carrier patrol under LT. A. Kipp to check the JOHANNES KERKHOVEN POLDER, a large expanse of reclaimed land on the RIGHT flank. The patrol was to work NORTH towards the REIDER SPIT. At the same time foot patrols made good progress though they were fired on several times by the Flak guns on the SPIT. The remainder of the company was now moving and advanced unopposed to 560220 and further to the LEFT to 555224. Six prisoners were taken. In these positions the troops were less than a thousand yards from the German guns and were even able to watch the gunners loading and firing. The only artillery available was now the 10.5 troop and later one 7.2 in howitzer and as the enemy positions covered a large area this number of guns was inadequate. No aircraft were available to bomb the target as the current attack on EMDEN had top priority. Prisoners stated that three hundred troops were on the SPIT awaiting ships and while the majority wanted to surrender, the gunners were determined to stay and fight. Lieut. R.E. Mannering came from “C” Coy to Tac HQ to put the C.O. into the picture as to what the situation really was. As an example, the number of Officers attached are shown with the Officer numbers and not separately as done occasionally in the War Diary.
